E-MAIL/FACSIMILE CONSENT FORM

I, _____, a member of the Pine Forest Owners' Association (PFOA), hereby consent to the transmission of all formal notices and other communications from the PFOA to me by electronic transmission (i.e, e-mail) and/or facsimile (i.e, fax). I understand the PFOA's policy is to transmit by e-mail and I will only receive transmissions by fax if I specifically request it. This consent extends to all written PFOA written communications, including without limitation, PFOA disclosure reports, rule change documents, notices of board meetings and member meetings, and other forms of communication required or permitted by PFOA's governing documents or California Law.

I understand that I have the right to withdraw my consent to receive PFOA communications by email and/or fax at any time without charge. To withdraw my consent to receive PFOA communications by electronic transmission, I may do so by notifying PFOA **in writing** at the following address:

I understand the PFOA generally retains copies of all electronic communications in electronic and/or hard copy form for at least 12 months after the date of transmission. I can request a paper copy of any electronic transmission by contacting the PFOA at the address above within 12 months of the date of the transmission. There is no charge for the first to 20 pages and a charge of \$0.25 per page for each page thereafter.

CAMCO uses standard computer hardware and software for transmission of e-mail and fax communications. I understand that I am responsible for configuring my hardware and software to receive PFOA electronic communications. CAMCO will use its best efforts to protect recipients from viruses or similar transmission problems, but is not responsible for such problems and I assume full responsibility for any such problems. PFOA strongly advises recipients to install and regularly update anti-virus and similar software for their own protection.

I also understand that it is my responsibility to notify CAMCO at the address above of any change in my e-mail address or fax number, and that it may take 7 to 14 days to complete the update.

CAMCO will use your electronic transmission address(es) for PFOA business only, and will not provide the information to others who are not working for or with PFOA, such as managers, attorneys, and accountants. Other PFOA members have the right to receive my regular mailing address for proper purposes, but they are not entitled to receive my electronic transmission address(es) without my consent. I DO _____, DO NOT _____ consent to CAMCO providing my electronic transmission information to other PFOA members until further notice.
